We, the People of the Holy Land, in order to form a Federation for the Holy Land, establish Peace, Equality, Freedom, Security, Stability, Justice and Democracy and to promote the general Welfare, to ourselves and our posterity, do ordain and establish this Constitution for the Federation of the Holy Land.

Introduction.

For thousands of years the Holy Land has been a battlefield. From the time of Abraham (Ibrahim) the offspring of Ishmael (the elder) and Izaak (the younger) fight. After the holocaust of World War II the World has given the sovereign powers of the Holy Land to the Jews. Today Jewish and Palestine powers claim separated, independent, sovereign countries with their own governmental system. The struggle continues.

We propose a Federation for the Holy Land, in which both powers; Jewish and Palestine, within the Holy Land will be independent and sovereign. The sum of powers in the federation however will be more than separate nations; the sovereign nations become the one Federation of the Holy Land.

Ideas from wise man from the past brought the global civilization from today. Inspired by the Highest, wise man like Moses, Confucius, Buddha, Jesus, Mohammed and many others like F.D. Roosevelt and Mahatma Gandhi gave us ideas to create the civilization of mankind. The world civilisation today suffers from the struggle between the Jews and the Palestine's within the Holy Land. This Constitution for the Federation of the Holy Land will give a step forwards towards a civilised Holy Land and a civilised world.

The history of the governmental development of Europe learns that a civilisation of a country is build through a contract between groups of people within a country. The contract for a government gives the democratic power to the people. This governmental contract brings Peace. This Constitution may be the contract between the people in and out of the Holy Land. Created to bring peace, prosperity and happiness.

The Federation for the Holy Land aims for equality of each member Nation. The federation of the Holy Land will stimulate Fundamentals like Equality, Freedom, Security, Stability, Justice, Democracy and Welfare. This Constitution gives a blueprint for a Federation of the Holy Land, in which all People and the member Nations stand for its Fundamentals.

Jerusalem, The Holy City.

For many thousands of years, Jerusalem has been the Holy City for Jews, Christians and Muslims. To confirm the Federation of the Holy Land, Jerusalem needs to be a free federal city, which has an authority of its own. There need to be no competition of authorities within this city.

Everyone is equal in worshipping I Am Who I Am.

Today, the authority for creating, executing and speaking Law is with the governments of the sovereign nations of the world. Eminent and wise religious leaders give governments their public advice for ruling. Government are legislated by the people through their public system.

Governments do not have the authority to address people how and where to communicate with I Am Who I Am or how to worship I Am Who I Am. Religious Books and religious leaders guide the people towards the personal communication with I Am Who I Am and towards the personal worshipping of I Am Who I Am.

Jerusalem, the Holy City with a history of thousands of years of I Am Who I Am seeking people, must be free of the public authority of just one group of people. Within the Federation of the Holy Land, Jerusalem will be the capital of the Federation of the Holy Land, the capital of Israel for the Jews and the capital of Palestine for the Muslims. Therefore Jerusalem needs its own authority.

The Palestine Nation.

The Federation for the Holy Land needs equal sovereign partners. Sovereignty has to do with property. At this point the borders of Israel and the Palestine territories and properties are well known. Therefore it will be possible to constitute the Palestine State as one of the sovereign partners in the Federation of the Holy Land.

Chapter I. Fundamentals.

The Federation of the Holy Land starts with balanced Fundamentals which are to be established in this Constitution. Each fundamental is of equal significance.

Section I-1. Freedom.

Freedom is the first step to a Federation of the Holy Land. Freedom without responsibility is freedom only for the strongest and the fittest. The Federation of the Holy Land aims for a balance between freedom and responsibility.

Art.1. There shall be freedom of speech and organisation.

1. The press and media shall be independent.
2. There shall be no personal or public deception.
3. There shall be no personal or public insult.
4. Every citizen may speak, write or communicate freely.
5. There shall be freedom of peaceful meeting and assembly.
6. Every inhabitant has the right to peacefully organise itself.

Art.2. There shall be freedom of expression.

1. Every citizen has the right for a private life.
2. Every citizen has the right to live with his or hers children.
3. Every citizen has the right of protection of its data.
4. Every citizen has the right of using its property in its own way.
5. Every citizen may have a place to live in its own way.
6. Every citizen has the right of viewing its private data.

Art.3. There shall be freedom of religion and conviction.

1. Every person may worship I Am Who I Am in his or hers way.
2. Every person may dress to the ways of the religion.
3. Every group of citizens may use a building for its religion.
4. Each citizen may honour the religions days.
5. There shall be free will in the equality in religion or conviction.
6. Only the government has the right to ordain and maintain written Law.

Section I-2. Equality.

Art.4. All are equal for the Law.

1. Man and woman are equal before the Law and I Am Who I Am.
2. People from all races and cultures are equal.
3. Able and disable people are equal.
4. The elder people are equal to the other people.
5. There shall be no discrimination.
6. The family is equal to the individual.

Section I-3. Security.

The security articles describe the fundamentals towards our citizens (people from our nation) and our inhabitants (citizens plus people from other nations).

Art.5. We will provide a secure Federation of the Holy Land.

1. Every person has the right for one nationality, and one only.
2. The mother decide the nationality of a child, hers or his.
3. Every inhabitant must identify itself and its nationality.
4. People without passport will be subjected to Law.
5. We will prevent terrorism.
6. We will establish internal security forces.
7. No one shall possess, bear arms except with license.

Art.6. We will provide a safe Federation of the Holy Land.

1. Every person has the right for life.
2. No death penalty shall be given.
3. People should not speak out a death wish to the other.
4. No man or part of man should be sold.
5. No one should be tortured, humiliated, molested or abused.
6. No one shall possess or use drugs except with license.
7. Children shall be protected.

Art.7. We will provide controlled immigration.

1. People from outside the Federation of the Holy Land may settle themselves, waiting for ten years, speaking the nation's language and being able to support themselves.
2. People from outside Federation of the Holy Land which are not able to support themselves must go back to their country of origin within three months.
3. People from outside Federation may work with a license.
4. Everyone persecuted on political grounds has the right to asylum.
5. There shall be yearly quota for immigration.
6. No citizen of the Federation of the Holy Land shall be banned.

Section I-4. Stability.

Art.8. We will stimulate a system for employment.

1. The employer is free to employ within civilised methods.
2. The maximum working hours weekly may not exceed 40.
3. The employer provides for occupation related education.
4. If a company makes a profit, every employee will equally benefit.
5. An employer should sober the wages of its management.
6. An employee may have several jobs.

Art.9. We will provide a system for unemployment.

1. We provide a system for illness, including a training to go to work.
2. We shall provide for the disabled people who cannot work.
3. We provide a civilised system for unemployment based on reality.
4. The system for unemployment has an education to change a job.
5. With resignation, the younger employed should precede the older.
6. Every employee may organize themselves into trade unions.

Art.10. We will provide a system for the undisturbed old-age.

1. From the age of 65 years all citizens may stop working.
2. From the age of 55 years all citizens may lower working.
3. All citizens from the age of 65 shall get an old-age pension.
4. There shall be solidarity for the health expenses of all ages.
5. Everyone has the personal right to deny reanimation.
6. Everyone has the right to burial to their own customs.
7. Everyone has the right to end its life.

Section I-5. Democracy.

Art.11. We will provide democracy.

1. There shall be universal, free, direct and secret elections for the Federation of the Holy Land.
2. Every adult citizen of eighteen (18) years and older has the right to vote and to be elected, except who is unable to vote or who is imprisoned.
3. People are chosen under the mandate and program of a political group.
4. For every main political issue there may be a referendum.
5. The public funds for elections and referendum shall be equally divided.
6. The President of each country within the Federation of the Holy Land shall have the political arbiter function.

Section I-6. Justice.

The legislative, the executive and the juridical powers shall be separated. The Federation of the Holy Land acknowledges free will, free choice and public responsibility.

Art.12. We shall implement international law practices.

1. Everyone is innocent until proven by Law otherwise.
2. Everybody has the right for a fair trial.
3. No one shall be convicted in doubt.
4. No one needs to cooperate in its own conviction.
5. No one shall be convicted for the same again.
6. Everyone has the right for professional juridical help.
7. There shall be a Constitutional Court

Section I-7. Welfare.

Art.13. We will establish Welfare for all of our people.

1. We will provide free education for children up to 17 years old.
2. We will provide free education for people who cannot read and write.
3. Children under the age of 17 should not be employed.
4. We will provide healthcare for each inhabitant.
5. We will provide sufficient infrastructure and housing.
6. Every child up to 18 years old will be guaranteed a safe home.
7. On the age of 18 children shall give one year to the society.

Art.14. We will take good care for the world we live in.

1. We will take good care for all biological life.
2. We will take good care for the fossil world.
3. We will take good care for the environment.
4. We will take good care for the waters.
5. We will take good care for the air.
6. We will take good care for the earth.
7. We will manage the climate change.

Chapter. II. Law and Order.

Section. II-1. The Laws.

Art.15. The Agreements.

1. All members agree to the statements and clauses in this Constitution.
2. This Constitution resolves all former agreements.
3. All versions of this Constitution shall be confirmed by Referendum.
4. Two-third of the people of each member Nation shall confirm this Constitution for the Federation of the Holy Land.
5. The Constitution shall not be changed for five years.
6. There will be Holy Land elections for the Congress of the Federation of the Holy Land after confirmation of this Constitution.

Art.16. The Transformation.

1. Every Nation must transform the Holy Land Laws into National Laws.
2. The National Laws must embrace the Fundamentals.
3. If National laws exist, than they overrule Laws from the Federation of the Holy Land.

Section. II-2. The Order.

Art.17. The Authorities.

1. There shall be free traffic of goods within the Federation of the Holy Land.
2. There shall be free travel of people within the Federation of the Holy Land.
3. There shall be a common fish and agricultural policy.
4. There may be one monetary union.
5. There may be the Holy Land Political Advice and Standardization.
6. More Authorities may be agreed to.

Art.18. The Membership.

1. Every Nation within the Holy Land may be member of the Federation of the Holy Land for one or more of its authorities.
2. The membership is confirmed by paying the contribution if possible.
3. In December of a year, a Nation says what authorities it want to share with the Federation of the Holy Land for the next year.

4. The membership will be suspended if the contribution is not paid in time.

Art.19. The Contribution.

1. For each authority a member Nation pays 1 currency unit of its Nation for each citizen or otherwise as agreed to.
2. Each Nation will have a public administration of its people.
3. The contribution year acts from 1th January to the 31stDecember.
4. The contribution must be paid for 1/12th each month of the year.
5. The contribution for a month must be paid before the first day of the next month.

Chapter. III. The Organisation.

All legislative Powers herein granted shall be vested in a Congress of the Federation of the Holy Land, which shall consist of the President, a Senate of Ministers, a House of Representatives, its Committees and the Council. The Congress will have its seat in the Federal City of Jerusalem.

Section. III-1. The Legislative Power.

Art.20. The Senate.

1. The Senate consist of twenty members of the Parliament of member States.
2. The Senate has the right for initiative of the Holy Land Programs and Laws.
3. The Senate agrees to the Holy Land Budget, Programs and Laws.
4. Voting about a the Holy Land Proposal needs common majority.
5. The Senate will have every six months a President from one of the member States.
6. The President will have the mandate to speak on behalf of the Federation of the Holy Land, in agreement with the House of Representatives.

Art.21. The House of Representatives.

1. The House of Representatives consist of one hundred members for each Member State.
2. The House of Representatives shall be composed of Members chosen every fifth year by the People of the several States.
3. He or she shall be a Citizen of a member State.
4. The House of Representatives has the right of initiative for the Holy Land Law Proposals and for the Holy Land Programs.
5. English will be the first language in the House of Representatives.
6. The House of Representatives will choose in the first meeting of January a Chairman, which will be responsible for the Organisation of the Congress.

Art.22. The Committee's.

1. The House of Representatives will have Committee's for debating the initiatives for the Holy Land Law and Programs.
2. Each Committee will consist of Representatives, one for each State.
3. Each Committee will choose each year, a Chairman from its midst.
4. Each Committee will agree with common majority about a Law Proposal.
5. There will be 18 Committee's for:
 - a) Internal General and Personal Affairs.
 - b) Internal Financial Control.
 - c) Foreign Affairs and Security.
 - d) Travel and Customs.
 - e) Immigration.
 - f) Trade and Internal Market.
 - g) Consumers.
 - h) Fishery, Agriculture and Livestock.
 - i) Infrastructure, Transport and Traffic.
 - j) Energy and Industry.
 - k) Social Security.
 - l) Environment and Climate.
 - m) Health and Healthcare.
 - n) Science and Education.
 - o) Monetary Aspects.
 - p) Culture and Sports.
 - q) Development.
 - r) Poverty and Humanitarian Aid.
- 6) More Committee's may be organised.

Section. III-2. The Executive Power.

Art.23. The Council for the Federation of the Holy Land.

1. The Chairman's of the Committee's will form the Council.
2. The Council will be the executive power for the Federation of the Holy Land.
3. The Chairman, the Secretary and the Treasurer from the House of Representatives will fulfil these functions also in the Council.

Section. III-3. The Juridical Power.

Art.24. the Holy Land Constitutional Court

1. The Holy Land Constitutional Court will be independent from the Congress.
2. the Holy Land Constitutional Court will have its seat in the Federal City of Jerusalem.
3. Every citizen from the Federation of the Holy Land may bring Constitutional cases for the Court.
4. Each member of the House of Representatives may bring a Nation to court if a Nation does not live up to the Agreements of this Constitution.
5. This Court does not question the Holy Land Law.
6. This Court will make its own Statutes.

Chapter. IV. The Finance.

Art.25. The Budget.

1. In January of each year, the Treasurer of the House of Representatives will present the Budget.
2. The income of the budget consists of the contribution of the member states and other income.
3. The expenses in the budget consist of ratified programs, specified to each committee and other expenses.
4. The Budget must be confirmed by an independent organisation.
5. The Budget will be published for the public in the languages of all member nations.

Art.26. The Bill of Expenses.

1. At the end of January each year, the Treasurer of the House of Representatives will present the Bill of Expenses.
2. The income of the Bill of Expenses consists of the contribution of the member states and other income.
3. The expenses in the Bill of Expenses consist of ratified programs, specified to each committee and other expenses.
4. The Bill of Expenses must be confirmed by an independent organisation.
5. The Bill of Expenses will be published for the public in the languages of all member nations.

Art.27. The Accounting.

1. At the beginning of each month, the Treasurer gives every Senator and every Representative an overview of the Expenses in relation to the Budget.
2. The Treasurer organises control and auditing on the Expenses in every member Nation, throughout the year.
3. The financial progress, which will include the progress of the Holy Land Programs, will be published for the public in the languages of all member nations.
